Dear Jane,

I understand you do not have a Parish Council but your meeting may like to consider proposal below.

Please see attached plan of a proposal to alter the public footpaths at Great Hagley, Hopton Castle.

The resident of Great Hagley run an outdoor pursuit centre which has vulnerable people amongst its clients. The current footpath runs through the yard where clients congregate and it is close to the buildings used for accommodation. There is a good network of paths available around the property providing links in all directions. The proposed path reaches a viewpoint by an unusual standing stone which was erected by previous residents to mark the Millenium. There are 360' views here before the path descends over grassland to rejoin original footpath route at the property boundary.

The applicants will bear the cost of the diversion and any new furniture that may be required. There will be one gate on the new route.

I would be pleased to receive your views on the proposal.

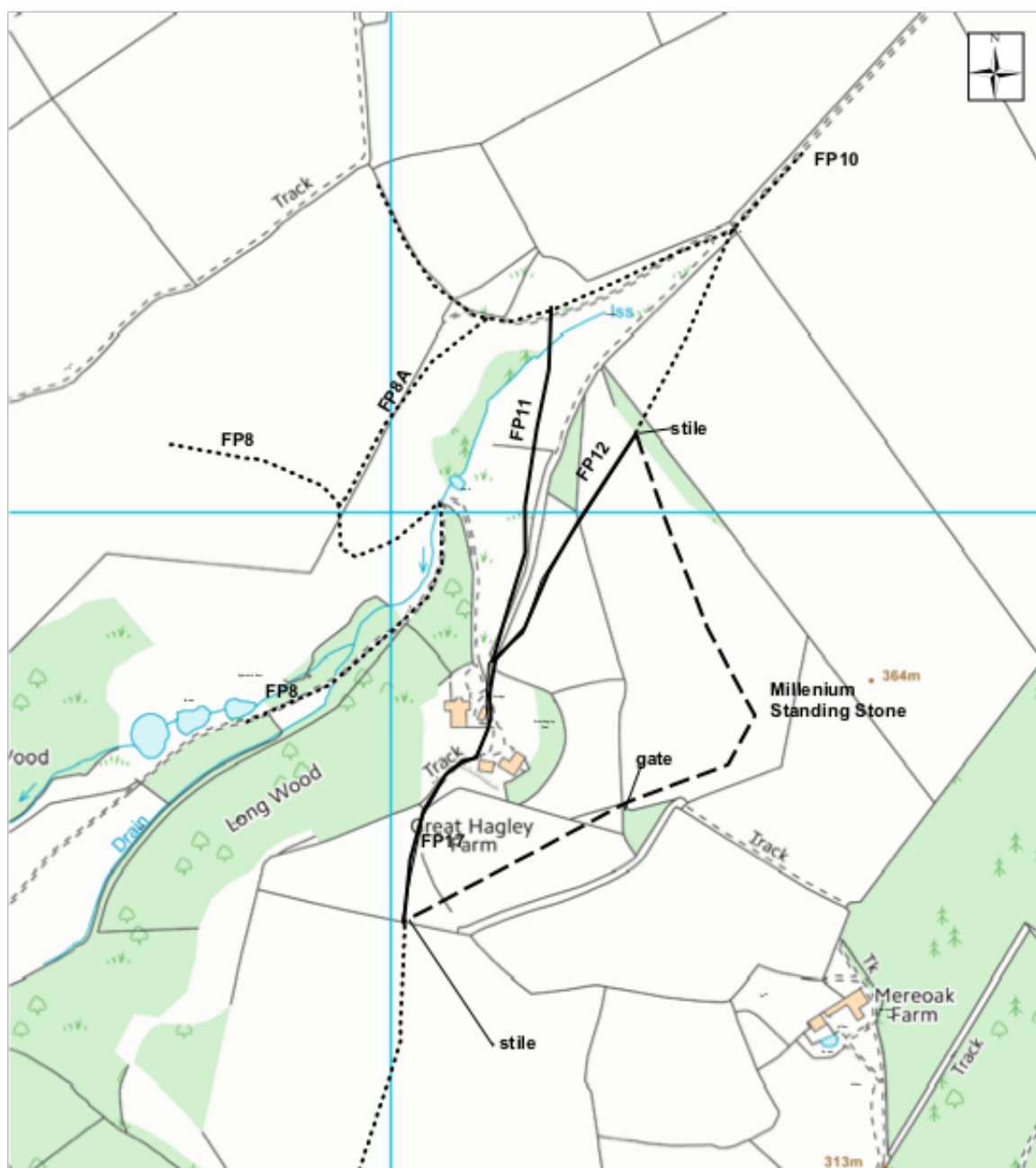
