3. What are the aims of your project? What do you want to achieve i.e. what are the project outcomes (end results)? Who will benefit from the project and how?

To enhance the village, approach roads and Castle grounds by planting wild flowers along the verges and on the Castle motte. To replace indigenous hard wood trees lost in the micro-burst of 12 August 2020 in the Castle grounds and to replace other trees lost in recent years to improve the attractiveness and bio-diversity value of the Castle grounds.

Local residents and visitors will benefit from these developments.


4. What is the need for the project and how have you identified it?(If possible show evidence of community support and links to broader strategies or policies, e.g. AONB Management Plan, Parish Plans).

At the Hopton Castle Parish Meeting (HCPM) in the autumn of 2020 the question was asked, "How can we collaborate with the Hopton Castle Preservation Trust (HCPT) to make our village more attractive for both residents and visitors?" A small collaboration committee was appointed and ideas were shared. Both groups have very limited funds but benefit from a number of fit and willing volunteers to undertake manual work. It has been resolved to enhance the village and the Castle grounds in such a way as to improve the bio-diversity, attract more birds, wild life and insects and make Hopton Castle a place of educational, historic and natural interest for visitors and the villagers alike.

5. What would the funding support?

What will the project actually do? What are its outputs? (at least some should be measurable) How will the work be carried out, who will do it, when will it be done? The fund would allow the purchase of a selection of native wild flowers and young indigenous hard wood saplings plus protective sleeves and materials to form fencing shields (as the castle grounds are grazed). The project will draw advice and species recommendations from Shropshire County Council AONB and Outdoors Pursuits sections, local farmers, Historic England and from the members of the Edgton group who have been successful in planting wild flowers along their roadside verges. There are currently few if any wild flowers in the verges of the lanes leading into and through Hopton Castle apart from patches of snow drops and planted daffodil clumps so we would plan to take photographs "before" and "after" to demonstrate the success of wild flower planting. We would like to plant a number of trees in and around the Castle grounds, subject to scheduled monument approval.



6. What expertise do you have and what partners will you be working with to undertake this work? Hopton Castle has a number of successful gardeners, some having won prizes for their exhibits in local shows. We would utilise this pool of expertise with the planting of both wild flowers and trees. One member of the HCPM and two trustees of the HCPT have planted fruiting orchards in their gardens over the last 10 years with appropriate supports and protective sleeves. Both groups have sustained records of arranging volunteer delivery of local works including litter picking, maintenance of the Castle grounds and clearance of the over-growth on the banks of the stream that runs through the village.

Both the HCPM and the HCPT have welcomed the collaborative plans to enhance the village and its environs. This application has, in principle, been approved by both the members of the HCPM and the trustees of the HCPT. The Trust has been advised that as the Castle grounds are a Scheduled Ancient Monument the tree planting will require Scheduled Monument Consent. Initial advice is that this will be gained and an application is being developed through consultation with Historic England. Final financial involvement, if any, would require the approval of the members of the HCPM and the trustees of the HCPT.

The tree planting could over-run depending upon when the SMC is achieved but, should this cause a delay, it is not expected to run beyond the end of 2021.

Grants will normally only be made for activity within a particular Financial Year (April to the end of March). This may mean breaking down longer projects and making an application for the part of the work which can be completed within the Financial Year. 11. How will your project benefit the Shropshire Hills AONB and how does it link to the conservation priorities for the AONB?(see guidance for details)

The wild flower roadside verge and Castle motte planting will undoubtedly conserve and enhance the natural beauty, landscape and heritage of the Shropshire Hills AONB. The tree planting will likewise improve immeasurably the natural attractiveness of the landscape in the valley and attract wildlife, birds and insects thereby adding to the biodiversity of the area.

We have a number of school and college visits each year to the Castle and its grounds and the projects proposed would definitely make such visits of greater impact, educational value and general interest.

12. How will you evaluate the success of your project and what plans do you have to share the results with others? Evaluation and dissemination are important, and you may want to build some capacity in your project and its budget for this.

HCPT monitor the number of visitors to the Castle and both groups would anticipate an increase in numbers visiting the village and the Castle and its grounds as a result of completing these projects. The "before" and "after" photographs would be shared with other villages and action groups planning to carry out similar projects.

13. Who will maintain the completed project and how will this be funded in the future?

The members of the HCPM and the trustees of the HCPT will monitor the maintenance of the individual projects in the village and Castle grounds respectively and agree an annual joint programme of work to sustain the completed projects. This would include the collection and disposal of verge waste following hedge and verge trimming by the local farmers. Both groups have limited budgets but have expressed a desire to provide ongoing maintenance support for their respective areas.
